Ordinance

The development of nursing professionals in Hong Kong needs effective governance of specialty nursing. We also require the legitimate coverage and protection under the legal system which will in turn benefit the population of Hong Kong. This is simply the reason for the PHKAN to strive for the establishment of HKAN. To meet the work planning, PHKAN has activated a task force to schedule the drafting the relevant ordinance within a year. Members of the task force include Dr. Susie LUM, Dr. Joseph LEE, Mr. Lester HUANG (legal advisor), Mr. Tony YEN (Solicitor), Prof. Frances WONG, Mr. WW TSANG, Ms. Sylvia FUNG, Ms. Gloria LUK, Ms. Adela LAI, Mr. Frederick YEUNG, Mr. Mick YEUNG.

The legal adviser has provided valuable advices to members for the preparation of documents and direction consensus. The chairman of the task force met the government officials and also invited nurse professionals and associated bodies to provide information on the ongoing consultation. An opinion survey will be started soon to capture broader views from various stakeholders. Your involvement and participation in this survey is crucial to the success of the future HKAN and nursing specialty development.

Health Carnival on 6 April 2013

The launching of the World Health Day is to mark the founding of World Health Organization (WHO). It is first celebrated on the 7th of April 1950. Every year, a theme is set to highlight an important global health agenda to arouse worldwide attention. Thus, World Health Day serves as an opportunity to enhance health promotion and protection to the community at large.

To celebrate WHO's World Health Day and to show our commitment to health promotion and protection, HKANPC and PHKAN had organized Health Carnivals in 2010, 2011 and 2012. The respective themes were: "1000 cities, 1000 lives" in 2010; "Antimicrobial resistance and its global spread" in 2011 and "Ageing and Health" in 2012. We aimed at promoting the health awareness of people in the community through various activities such as booths, games, health counseling and health talks. Each year, the World Health Day was well received.
